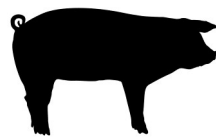

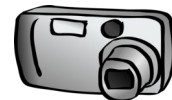

**REMINDER! Gilts & Barrows Allowed in the Market Hog Contest**

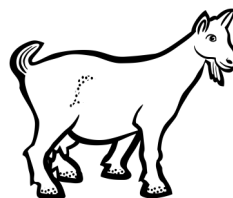

### Community Service Grants

You will be notified by CSB if your project is selected for funding. Completion date for all projects is expected to be on or before September 1st of the current year

### Add/Drop Deadline

Members wanting to exhibit their project(s) in the Holmes County Fair or State Fair must be enrolled in the project by Monday, June 1. Please contact your club advisor if you need to add or drop a project. The advisor will then contact the OSU Extension Office with the change.

### Tax Filing Reminder

Just a reminder - All chartered 4-H clubs and duly authorized eligible & qualified 4-H affiliated organizations must file the appropriate 990 tax form on time. 990-N (e-Postcard) filing must be made by May 15, 2016 for the Tax year of January 1, 2015 to December 31, 2015. Filing the 990 or 990-EZ or 990-N (e-Postcard) is the club's responsibility and the Extension Office staff cannot provide professional tax advice about filing the tax forms.

Advisors who filed prior to April 15 may have experienced difficulty as the IRS is transitioning to housing the process internally.

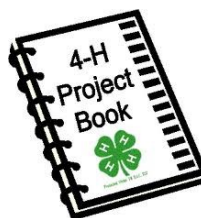
### “Kid’s Day” at the Holmes Co. Fair!

### Public Speaking

Speaking contests, illustrated talks, and demonstrations have long been a great training ground for Holmes County 4-Hers, helping them with public speaking skills that translate into better classroom performance and skills to persuade others on important issues. Members interested in the Health & Safety Public Speaking or Skit Contest will be sent to the Regional Contest in Wooster (OARDC Fisher Auditorium, TBA). Members have the option of preparing an Individual Health and Safety Speech or a Team Talk/Skit (2 or more members) on a Health and Safety topic. Topics can be anything related to health and safety that affects family living, whether it is in the home, on the farm, on the highway, or in public places.

Demonstrations can be fun for 4-Hers who teach other club and audience members a new skill. It could be anything from how to make a prize winning brownie recipe to skills in refinishing a family heirloom. ### Evaluation Dates

Please plan your schedules with these dates in mind. Youth must attend the scheduled evaluations in order to qualify for county and state awards.

- Life Skills Evaluation (including Food & Nutrition Projects): Thursday, July 14, 4 - 8pm at Baker Building
- Livestock Evaluation & Skillathon: Thursday, July 21, 4 - 8pm at Baker Building

Again this year, we will be offering 2 pre-judging events staffed by 4-H Volunteers prior to the scheduled County Project Evaluation events.

- Pre-judging Day 1, all projects – June 27, 4:00-7:00 p.m. @ Baker Building
- Pre-judging Day 2, all projects – June 30, 4:00-7:00 p.m. @ Baker Building

Members who are unable to attend the County Project Evaluation events, will need to call the OSU Extension Office to schedule a time for their pre-judging. Pre-judging appointments will be booked on a first-come, first served basis. Members who come to pre-judging without an appointment may be required to wait for an open appointment. Projects that are pre-judged will not be eligible for County Awards and State Fair participation. Pre-judging attendees will also be asked to complete a Skillathon station for animal projects this year.

The day camp will provide 4-H Cloverbuds an enjoyable and educational event of their own to look forward to at the state fair. Objectives for this year's camp are gain new knowledge, meet new friends to develop social and learning skills, and explore the Ohio State Fair. We are looking forward to continuing this annual opportunity for 4-H Cloverbuds which promises to be an educational and fun event!

## Holmes County Cloverbud Day Camp @ The Baker Building

Holmes County will be hosting Cloverbud Day Camp on Saturday, May 7th from 9:00 a.m. to 2:00 p.m. Check-in will begin at 8:30 a.m. All Holmes County youth of Cloverbud age, Kindergarten through Grade 2, are invited to participate whether they are enrolled in 4-H as Cloverbuds or not. Youth will be participating in activities which explore topics of: leadership, communication, teamwork, nature, crafts, service.

## Continuing Education Requirements for Volunteers

Starting last year, Holmes County instituted an annual volunteer continuing education requirement. 4-H is all about learning and we want to encourage our volunteers to continue life-long learning as well. Simply put, each volunteer will be required to complete at least one (1) continuing education event each calendar year. Failure to fulfill this requirement by December 31 of the current year will be seen as resignation of your volunteer status.

The Ohio State University Board of Trustees recently approved significant changes to the University's Youth Protection Policies (also known as OSU Policy 1.50). Since OSU Extension and the Ohio 4-H Youth Development program is part of The Ohio State University, 4-H staff and volunteers are subject to the University's policies and must comply. One of the requirements established by the board of trustees is that all OSU volunteers must attend annual training on Recognizing and Reporting the Signs of Child Abuse and Neglect. This training will count as the Continuing Education Requirement.



**All 4-H advisors, volunteers, and committee members must attend one of these trainings to be eligible to continue as a 4-H advisor, volunteer, or committee member in 2016. All scheduled trainings have been held, so if you still need to complete the training, please contact the Holmes County Extension Office.**

## Dress Code for Project Evaluations

It's never too early to start thinking about project evaluations. Please pay close attention to the dress code below. This has been in effect since 2010. Members not meeting these guidelines at any project evaluation event (Pre-Judging, Life Skills Evaluations and Livestock Project Evaluations), WILL lose points or be marked down at least one level.

- \* Clean pants, skirts or dresses that fit properly. Shorts and capri pants are not allowed. Skirts and dresses must be fingertip length or longer.
- \* Clean shirt or top that fits properly. Writing or images on shirts that may be considered offensive or inappropriate are not allowed. Tops, sundresses, etc. must have shoulder straps of 1-inch or wider.
- \* No hats worn during judging. Hats that are part of an ensemble or costume should be removed when speaking with judges.
- \* No flip-flops.



## Quality Assurance

There will be several QA opportunities in 2016 in Holmes County. Many other opportunities exist including special clinics and events. As a reminder any youth taking a market or lactating project must complete QA. Here are the events that are currently scheduled:

- \* April 26th, 7:00 pm at Baker Building
- \* May 5th, 7:00 pm at Winesburg Fire Station
- \* May 21st, 1:00 pm at Baker Building (Will be first hour of Bunny Day Camp, but all Holmes County youth are welcome to attend QA portion).

The Test Out option will also be offered this year. Cost remains at \$5. Members ages 12-18 may take a QA test. If they pass (70% or better), they will be exempt from QA up to 3 years. Tests will be given by appointment only. Tests are available March 1 thru May 31, at the OSU Extension Office on Tuesday, Wednesday and Thursday 9:30am - 5:30pm.

## 4-H Membership Across County Lines

Reminder: If your club has members that do not live in Holmes County (permanent/primary address), they must complete a Request for 4-H Membership Across County Lines form. This form can be found on our website ([holmes.osu.edu](http://holmes.osu.edu)) or picked up at the OSU Extension Office. Youth may only participate/exhibit as a 4-H member in one county.

The form only needs to be submitted once. Approval must be given by the Extension Educators in both the county of residence and county of request. After approval, the Across County Lines membership may continue until the youth ages out of 4-H. However, if there is no support for OSU Extension/4-H in the county of residence, then the Across County Lines Membership will terminate at the end of the current 4-H year.

## Livestock Requirements for Fair Exhibition

Enrollment in livestock projects includes several steps if an animal will be taken to the fair:

1. Enrollment in a 4-H club or FFA Chapter;
2. Attending Quality Assurance (if it is a market or lactating animal);
3. Having the animal tagged and/or weighed at the county weigh-in or tag-in;
4. Turning in the proper paperwork per species requirements to the Extension Office as listed below.

All are due in the Extension Office by Monday, June 1 in order to participate in the Holmes County Fair.

- Dairy Projects: Project Leases; Birth dates, Registration # or other ID.
- Beef Projects: Heifer and Feeder Calf Leases, Grooming Form
- Horse Projects: Identification page, Photo, Lease, PAS Entry Form and Permission to Participate in 4-H Horse Activities and Release of Claims.
- Llama Projects: Lease, IRL Registration (if applicable) and Photo.
- All Breeding Animal Projects: Project leases

In order to assist the youth in understanding their project and the expectations of show, Horse Committee will be hosting a Miniature Horse Clinic on Sunday, May 1st, 2:00 p.m. at the Old Fairgrounds. Topics to be covered include:

- \* Showmanship
- \* Tail in Hand
- \* Miniature Horse Jumping
- \* Miniature Horse and Carts



## Bunny Day Camp

The Holmes County Rabbit Committee will be hosting a Bunny Day Camp at the Holmes County Fair Grounds on Saturday, May 21 from 1:00 – 4:00 pm. The first hour will be Quality Assurance which can be attended by anyone needing Quality Assurance.

Topics may include nutrition, health, housing, supplies, breeds (commercial & fancy), certain breed disqualifications & general disqualifications, grooming, hands on showmanship, skillathon, breeding (palpating), marketing (products), & meats. 4-Hers wishing to practice showmanship may bring their rabbits to the clinic. This event is free and open to all 4-H members. The Committee will also be hosting a silent auction and refreshment stand. All proceeds benefit the new Fairgrounds.

## Dairy Feeders - Vaccine Reminder!

Mandatory Dairy Feeder Vaccination Program. At Tag-In, all dairy feeders will be given an injection of Bovi-Shield Gold One Shot™ (covers 4 major viruses & Pasteurella) administered by East Holmes Veterinary Clinic staff member. Cost of the vaccines is being sponsored by the Market Livestock Sale Committee. Animals not vaccinated will NOT be able to exhibit at the Holmes Co. Fair.
