2022 HOLMES COUNTY FAIR ROYAL COURT APPLICATION PACKET

Thank you for your interest in applying to be on the 2022 Holmes County Junior Fair Royal Court! Enclosed in this packet you will find the qualification of candidates, evaluation process, expectations of the royal court, and other pertinent information. Below are some friendly reminders of what needs to be submitted in order to be a candidate as well as important dates and reminders.

Application Components due by Friday, July 15 to OSU Extension Holmes County

1. A completed Royal Court Application which includes:
 - a. Holmes County Jr. Fair Royal Court Cover & Bio Sheet
 - b. Candidate Resume – example format included
 - c. **One Page** Essay on why he/she should be selected to represent Holmes County as the Junior Fair King or Queen.
 - d. A reference letter from adult in your life (4-H Advisor, FFA Advisor, or other) in a sealed envelope. This letter cannot be from a family member.
 - e. Signed consent form (also included in this packet).
 - f. A physical or digital photograph (to be used by media in promotion of contest).

Interviews will be held on Monday, July 25

1. Interviews will begin at 6:00pm in the Baker Building.
2. Professional attire should be worn.
3. Applicants are expected to remain until all candidates have been interviewed.

The royal court will be crowned on Monday, August 8

1. The court will be crowned at 4:30pm in the Large Arena.
2. All applicants are asked to be in the Junior Fair Board office dressed and ready by 3:45pm to prepare for the event.
3. Queen contestants are to wear a formal gown; king contestants are to wear dress slacks, button down shirt, and a tie (jackets are not required).

2022 JR. FAIR ROYAL COURT CONTEST GUIDELINES

Program Mission:

It is the mission of the Holmes County Junior Fair Royal Court contest to identify and select youth who embody the values of the organizations which they represent as the ambassadors of the Holmes County Junior Fair. These individuals will have a demonstrated record of working for the betterment of their community which will be further supported through their role on the Holmes County Junior Fair Royal Court.

Qualification of candidates:

Any Holmes County 4-H, FFA, or FCCLA member in good standing with their club who is at least 16 to 18 years old as of January 1 of current year may submit an application to apply for the Junior Fair King and Queen Contest.

General Information:

- The royal court will be made up of a Junior Fair King, Queen, and one king and queen attendant.
- Applications are available from the OSU Extension Office and holmes.osu.edu. Applications must be submitted no later than July 1 of the current year and must be submitted with signed consent form.
- Interviews will be held on Monday, July 25 at 6:00pm in the Baker Building. Applicants are expected to remain until all candidates have been interviewed.
- The royal court will be crowned on Monday, August 8 at 4:30pm in the Large Arena.
- Professional attire should be worn for the interviews; formal dress should be worn by queen contestants for the crowing and king contestants should wear shirt, tie, and dress pants. Jackets are options and tuxedos are not necessary.

Evaluation process:

- Written application (accomplishments & achievements)
- One-on-one interview (poise, personality, personal appearance)
- 10-minute tour of fairgrounds (public speaking)

Expectations of royalty:

- Attend (and bring parent or guardian to) new royalty orientation following coronation on Monday of the fair
- In all public appearances, be in professional attire and act courteous. Royalty should appear wearing crown and sash whenever appearing in official capacity.
- Assist with livestock and miscellaneous shows during the 2022 fair and Monday of 2023 fair
- Public spokesperson for Holmes County Fair at: county fairs across Ohio, local festivals/parades/events
- Queen to participate in the Ohio Fair Queens contest in Columbus in January 2023
- Other duties as assigned

Awards:

Queen and King will each receive:

- An embroidered chair
- Sash
- crown (queen only)
- \$1000 scholarship*

King and Queen attendant will each receive:

- A sash
- crown (queen attendant only)

Award guidelines:

Scholarships will be awarded to the king and queen. In order to receive those scholarships, they must attend and or participate in the events and activities listed on additional attached sheet. Photo evidence of attendance will need to be provided to Jr. Fair King and Queen superintendents, Janessa Hill and Ella Lorentz. These photos will be used as promotion on social media, in local news outlets and potentially other marketing purposes throughout your reign.

NOTE:

Selection by the Holmes County Fair Royalty Program as a title-holder (King, Queen, Attendant, etc.) is a privilege and shall be treated as such. If selected, you will be expected to fulfill your responsibilities with grace, dignity, and courtesy at all times. Your behavior will represent the highest moral standards and social graces at all times. If selected, you will represent Holmes County and the Holmes County Junior Fair program and it is expected you will provide a positive impression to all whom you interact with during your reign.

If selected, you will serve at the pleasure of the Holmes County Agricultural Society Board of Directors. The Board of Directors may, at any time and without advanced notice or procedure, revoke or rescind any title conferred at any point during your reign. Revocation of any title is at the discretion of the Board of Directors and may not be appealed. Revocation of any title will trigger the immediate duty to return any and all prizes, gifts, etc. from the time the title was conferred until the date of revocation.

LOCAL PARADES, FESTIVALS, & OTHER PUBLIC EVENTS

All royalty may attend the parades and festivals; we ask that the king and queen coordinate who is attending if they cannot be present themselves. Royalty will provide their own transportation through the parade; signage will be provided as well as assistance with parade registration. Other public events may count towards your required number of attended events and must be approved by superintendents and committee. King and queen must personally attend at least 3 of the parades/festivals to receive scholarship dollars.
