## Considering a Dairy Cow/Heifer Project?

The following are project requirements and guidelines for Holmes County 4-H Dairy Projects.

#### **Members must:**

- ☐ Enroll in 4-H by the April 1 Deadline
- □ Attend Quality Assurance training (if taking a market or lactating project)
- □ Dairy Livestock lease forms uploaded to 4-H online Animal Tab by June 1, 2023.
- □ Animal Visits will be conducted in June by
   Committee Members (for cows and heifers)
- ☐ Complete Project Book and attend Livestock

  Judging and Skill-a-thon (July)
- □ Submit fair exhibition reservations online in FairEntry (if exhibiting at the fair) between 6/1 and 7/1. (Formerly called "pen forms").
- ☐ Bring Cow/Heifer to the Fair at scheduled time

The Holmes County Fair Book lists all exhibition rules and requirements. It is posted on Harvest Ridge website and paper copies are available at the Extension office.

### **Equipment & Cost Considerations**

- Cows/heifers need a minimum of 200 sq. ft. for their pen, adequate bedding, and access to pasture.
- They require regular exercise, brushing and washing.

- Dairy Resource Handbook
- Ohio Dairy Palooza- April 15, 2023

#### **Show Information**

- Showmanship is optional but attendance at Dairy Sale is mandatory.
- Proceeds of the Dairy Sale will be divided among the dairy cow and heifer exhibitors using a points system which will reward exhibitors based on their performance in Book Judging, Showmanship, and Project Exhibition at the fair. See the fairbook for point details.

## Exhibiting a Dairy Project

#### Items needed for the fair:

- Must provide your own water bucket
- · Show box that locks to keep your supplies in
- · Feeder, feed tub or pan
- Rice brush
- · Shampoo, Soap & Adhesive
- · Chute and blower
- Rope halter, Neck rope, & Show halter
- Show stick

**Dress code:** White trousers and white shirts. Breed logo/production is acceptable, but farm promotion will not be allowed.

#### **Additional Information**

- All exhibits must conform to Livestock Exhibit Health Requirements listed in the fair book and as outlined in the National Dairy Farm Program Manual, which can be found at: <a href="https://www.nationaldairyfarm.com">www.nationaldairyfarm.com</a>
- Dairy participants are limited to one animal, per exhibitor, per class. Exhibitors must use their project animal for showmanship classes.
- All Dairy Heifer and Cow project exhibitors <u>must</u> turn in **two** thank you cards for Dairy Sale Buyers at Project Judging/Skillathon, **prior to fair** (or when picking up back numbers for the show).
